NEW for 2020

SPECIAL ELECTION TO FILL VACATED STATE REPRESENTATIVE DISTRICT 30A SEAT

Due to a vacancy in the State Representative District 30A seat, the City of Big Lake will be holding two Special Elections to fill the vacated seat prior to the start of Session. All three City voting Precincts will be open from 7:00 a.m. to 8:00 p.m. and voters are required to vote at their designated polling location. Polling location information can be found at the MN Secretary of States website at: <https://pollfinder.sos.state.mn.us/>. Special Elections will be held on the following dates:

TUESDAY, JANUARY 14, 2020 for the Special PRIMARY Election

TUESDAY, FEBRUARY 4, 2020 for the Special GENERAL Election

PRESIDENTIAL NOMINATION PRIMARY ELECTION

In 2016, legislation was passed establishing a **PRESIDENTIAL NOMINATION PRIMARY**. The current election law specific to the presidential primary is in Minnesota Statutes Chapter 207A and Minnesota Rules Chapter 8215. Common questions about the presidential primary are answered below:

When will the Presidential Nomination Primary take place?

TUESDAY, MARCH 3, 2020. Polls open at 7:00 a.m. and close at 8:00 p.m.

Will all parties participate in the presidential nomination primary?

No, only **major political parties** will participate. There are now four major political parties in the State of MN (listed alphabetically): Democratic-Farmer-Labor Party, Grassroots-Legalize Cannabis Party, Legalize Marijuana Now Party, and Republican Party.

Will all parties be on the same ballot?

No, each major party will have a separate ballot.

Who decides which candidates will appear on a party's ballot?

The chair of each party will submit a list of candidates for the party's ballot no later than 63 days before the presidential primary (December 31, 2019).

What if a candidate drops out before the primary?

Once a party's list is submitted, changes will not be made to candidates that will appear on the ballot.

Will there be a place to write in a choice or vote for "uncommitted"?

Only if it is requested by the party chair. Party chairs will need to submit names of write-in candidates to be counted seven days before the primary.

Will any other offices be on the ballot?

No, only presidential candidates from a major party will appear on the presidential primary ballot. Other offices with a primary will be on the primary ballot in August.

2020 City of Big Lake Election Update Continued

How will I be able to vote in the presidential nomination primary?

Registered voters will be able to vote at their polling place on presidential primary day or by absentee ballot in the 46 days before presidential primary day (starting January 17, 2020). To find out where you should vote, log onto the MN Secretary of State's website at: <https://pollfinder.sos.state.mn.us/>.

A voter must request the ballot of the party of their choice. If a voter refuses to select a party, they will not be able to vote in the presidential nomination primary.

Will other people know which party's ballot I request?

A voter's choice of party ballot will be recorded and is private data. However, a list of who voted in a presidential nomination primary and the political party each voter selected will be provided to the chair of each major political party. How a voter voted on the ballot will be secret.

Will parties have to abide by the primary results?

The presidential primary results must bind the election of delegates in each party.

Who will pay for the presidential nomination primary?

County and municipalities will be reimbursed by the state for specific primary costs.



How much will the primary cost?

The Office of Secretary of State surveyed all 87 Minnesota Counties and, based on that survey, estimates that the cost to administer the Presidential Nomination Primary will be \$11.9 million. The Secretary of State has certified this estimate to the Commissioner of Management and Budget. Counties and municipalities will be reimbursed for specific costs of administering the Presidential Nomination Primary following the election.

Will there still be precinct caucuses?

Yes, precinct caucuses and local and state nominating conventions will still take place to conduct other party business. Precinct caucuses will be held February 25, 2020, one week before the Presidential Nomination Primary.

Precinct caucuses are meetings run by Minnesota's political parties. They are the first in a series of meetings where parties may endorse candidates, select delegates, and set goals and values (called party platforms).

The Presidential Nomination Primary includes requirements and procedures that are different than what Minnesota voters have known for previous state primaries. Most notably:

- ⇒ The requirement that one must state their major party preference;
- ⇒ A voter will be given a presidential "primary" ballot with only those party's candidates on the ballot;
- ⇒ There will only be the one office (president) on the ballot and it will be one name only (not a team);
- ⇒ A party may choose to have "uncommitted" and "write-in" items on their ballot; and
- ⇒ The choice of major party ballot is private, except that it will be shared with the chairs of the major parties after voting history has been entered for the election.

Other 2020 Election Dates:

- ⇒ **TUESDAY, AUGUST 11, 2020 for the PRIMARY ELECTION**
- ⇒ **TUESDAY, NOVEMBER 3, 2020 for the GENERAL ELECTION**



Tis the Season for Snow Removal



Section 550 - Sidewalks: 550.01 Clean Walks Required. The owner or occupant of any premises in the City shall clear the sidewalk in front of or beside the premises, of snow and loose or melting ice within twenty-four hours after the completion of any snowfall.

The City received numerous complaints in previous winters regarding sidewalks which were not being consistently cleared of snow. Big Lake is a walkable community and many residents, especially children and those with physical handicaps who cannot drive, rely on the sidewalk system to safely navigate their neighborhoods and access community resources. It only takes one snowy/icy

sidewalk section to force pedestrians into the road where their safety is compromised.

If a sidewalk is found out of compliance with the ordinance, the City's authorized contractor will clear the sidewalk and the property owner will be sent a bill. The bill will include an administrative fee as well as the cost of the contractor's hourly rate. The City's authorized contractor will be performing a *sweep* of the City's sidewalk system following any snow event that drops at least two inches of snow on the City or any series of snow events that leads to over two inches of accumulation. The authorized contractor will clear any snowy sidewalks and the property owners will be billed accordingly.

The City will always provide notice on its website and Facebook page before a *sweep* takes place and the City will always wait at least 24 hours after the snow has stopped before each sidewalk *sweep*. Please note that property owners must shovel their sidewalks even if less than two inches of snow has fallen. In addition to the automatic *sweeps* after heavy snowfalls, the City will also be sending out its authorized contractor to respond to complaints about un-shoveled sidewalks after any snow event.

Snow Season Reminders

- ⇒ Please keep in mind, property owners are responsible to clear snow around their mailbox. The City will consider making repairs to mailboxes only if the snowplow equipment *physically* hits the mailbox or post, and only if the mailbox conforms to City Ordinance installation requirements. Contact Big Lake Public Works at 763-263-2268 with mailbox complaints.
- ⇒ To prevent damage to lawns, landscape, irrigation heads or other items that will get buried under the snow along the curb or edge of the road, it is recommended that residents clearly mark these areas with reflective stakes.
- ⇒ It is illegal to deposit snow on any City street.



Winter Parking

Parking is not allowed on any City street or roadway between November 1 and April 1 of each year, during the hours of 12:01 a.m. and 8:00 a.m.

- ⇒ After a snowfall of two inches or more, all streets in the City will be cleared of all motor vehicles for the purpose of snowplowing and/or snow removal.
- ⇒ If your vehicle should have mechanical failure and cannot be removed from the street during the required dates/times, please contact the Big Lake Police Department at 763-251-2996 and advise the officer on duty. This may help in avoiding a citation and/or your vehicle being impounded.



Municipal Liquor Store

Big Lake Police Department Partners with Neighborhoods



The world of social media and online services continues to evolve at a head spinning pace. At your Big Lake Police Department, we currently work diligently to stay ahead of the curve and to engage with our community in a variety of very successful avenues. We currently have nearly 11,000 people following us on Facebook. If you are not amongst those, please join along for the ride at facebook.com/biglakemn.org/. Our next highly successful social media platform has been through the new-comer to the block, Nextdoor.com. We have nearly 1,800 households joining us on this platform. You can also join along with us at nextdoor.com/agency-detail/mn/big-lake/big-lake-police-department/. Nextdoor.com allows us to push out alerts specific to our 21 designated neighborhoods and receive alerts which have a critical public safety message.

Over the past year, the use of cameras in residences has become a rapidly growing home security measure and a source of evidence to solve many crimes for law enforcement. There are a number of quality vendors including Arlo, Nest, and Ring just to name a few. Each of these services has its own ability to share activity with your neighbors through their product. In November of 2019, the Big Lake Police Department went live with a new program developed by Ring, which allows all video users to share their information through one application called "Neighbors." Through the Neighbors App you can:

- ⇒ Share video you captured and a message, with a designated area you create on the interactive map.
- ⇒ Receive information from others using the Neighbors App.
- ⇒ Share suspicious activity directly to the Big Lake Police Department.
- ⇒ Receive requests from Big Lake Police for video related to an incident occurring in your neighborhood.
- ⇒ Share and receive video, even if you are not a customer of Ring.

We will be pushing this program out in January 2020, with more information at that time. Download the Neighbors App and give it a try! We are excited to move forward with this new program. As always, please be responsible with what you post, and please contact your Big Lake Police Department with suspicious activity occurring in your neighborhood. Thank you for reading our article! As a department, we would like to recognize and give a special thanks to firefighter Eric Rosa for heading up the fire prevention events in 2019.
