
Median Household Income for Sherburne County is \$88,824, almost \$10,000 more than the Greater MSP's median income of \$79,087.

In the last decade (2008-2018), Sherburne county's population grew by 9.5%. It was the 10th fastest growing county in Minnesota out of 87.


Sherburne County is projected to have a faster rate of growth than Greater MSP and Minnesota in the next five years.

7.7% of the population are people of color. Significantly lower than the region's share of 23%.


Highway and Rail Service

- Sherburne County has two divided highways that run north-south, U.S. Highway 169 and East-West, U.S. Highway 10 and Interstate 94 that runs parallel to the western boundary of the County.
- Rail Service is provided by BNSF, which also carries Commuter Rail (NorthStar) that connects the county to Downtown Minneapolis.



- Average commute time for Sherburne County residents to work is 32.4 Minutes, higher than Greater MSP commute time of 25.3 minutes.

42.7% of Sherburne County's population has an Associate's degree or higher.




- Agriculture is the most concentrated industry group by employment in the County; it is over 3x times more concentrated in the county than the nation.

- Accommodation and Food Services had the largest employment growth between 2014-2019, increasing by 23%.

- Fabricated Metal Product Manufacturing is the largest employing manufacturing sub-industry in the County, employing over 1,400. The sub-industry also has the most businesses in the County with 58.
- Furniture and Related Product Manufacturing has the largest concentration in the County; the subindustry is nearly eight times as concentrated in the County than the nation as a whole.
- Food manufacturing grew the fastest over the past five years, nearly doubling the number of jobs from 128 to 223.

Roughly one third of Sherburne county businesses employ less than 5 people, and another third (32%) of Sherburne County companies employ between 10 to 49 people.
